RESOLUTION NO. 16—REAPPOINT MARK MIKOLAJCZYK TO CODE/ZONING OFFICER

Councilman Martin offered the following:

WHEREAS, Mark Mikolajczyk resigned his positions as Code & Zoning Officer to comply with his retirement with the New York State Retirement System; and

WHEREAS, Mr. Mikolajczyk had to be off work for twenty-four (24) hours to secure his retirement; and

THEREFORE, BE IT RESOLOVED, that Mark Mikolajczyk be reappointed to the positions of Code & Zoning Officer for the Town of Oakfield.

RESOLUTION NO. 17—REJECTION OF ALLIED BUILDERS BID

Deputy Supervisor Veazey offered the following:

WHEREAS, on the day of the BID opening Allied Builders, Inc. was the apparent low bid the General Construction Contract with a Base Bid Amount of \$1,097,000; and

WHEREAS, on March 18, 2015 a representative of Allied Builders, Inc. contacted the Town and stated that there was an error in their BID, as they omitted the required Allowances totaling \$100,000; and

WHERAS, a meeting was held on March 24, 2015 with representatives from Allied Builders, Inc, Clark Patterson Lee and the Town of Oakfield to discuss the Bid. It was determined that Allied Builders, Inc. could not complete the project honoring their Bid price and including the omitted Allowances;

THERFORE, BE IT RESOLVED, that the Town of Oakfield rejects the Bid from Allied Builders, Inc.
