BOARD MEETING

MAY 10, 2011

The meeting was called to order at 7:00 pm by Deputy Supervisor James Veazey, followed by the Pledge to the Flag.

PRESENT: Councilpersons Veazey, Glor, Kabel and Cianfrini, Superintendent of Highways Dennis, Code and Zoning Officer Smith, Town Clerk Haacke, Assessor Flansburg

ZONING & CODE OFFICER

Mr. Smith wrote an order to comply to a South Pearl Street Road resident; there is garbage and junk on the property. Two letters were sent to the resident, one regular mail the other certified; the certified confirmation has yet to be received by the Town. Mr. Smith knows she received the letter regular mail because she called him and asked for an extension of time to comply. She is elderly and the people who she has hired did not show up. Mr. Smith gave a ten (10) day extension, to May 20, 2011.

Two permits have been issued for pools and two zoning permits for agricultural buildings.

ASSESSOR

New York State requires the Assessor to sit with the tax roll for two hours prior to grievance day; this is the assessor's night. Mr. Flansburg is scheduled to be in the office until 9:00 pm this evening. The tentative roll is done; just waiting on the state to determine if we are at 100%.

LITTLE LEAGUE

Shelly D'Alba was here to represent Little League. A letter was written to Supervisor Dodd regarding the play schedule for the 2011 season. As soon as Little League has the All Star Schedule that will be forwarded to the Supervisor as well. Mrs. D'Alba asked the Board if they had time to consider the request of Mr. Bradt at last month's meeting, which was to construct a cement pad near the batting cages to store the dirt. A <u>motion</u> was made by Councilperson Glor, seconded by Councilman Kabel and carried by unanimous vote to allow the Little League to construct a cement pad near the batting cages.

SUPERINTENDENT OF HIGHWAYS

Road work---summer work has begun

Ditches have been cleaned of garbage, including tv's, tires, etc.

Cemeteries have been graded off

In the process of cutting trees

Culvert pipe on Hutton Road

Scheduling roadwork

Buildings & Grounds---all the electric upgrades have been done at the Town Building and the Town is now PESH compliant.

Survey costs---to have all the land the Town of Oakfield owns surveyed will cost \$3,700.00. Should the surveys be done, permanent pipes will be placed at the boundaries. Judge Road cemetery must be done because of the additional ground for future burials. The Recycling Center must also be done, it was

discussed that the Town would Quit Claim the portion of the pond at the Rec Ponds. It was stated by Councilman Cianfrini that he would contact Mr. Townsend should the Town decide to go forward with the surveys to have him draw up a meets and bounds description to form a description of a deed so the Town is completely out of that area. The Town does however, want to keep the driveway. Payment for this will come from General Fund.

A <u>motion</u> was made by Councilman Cianfrini, seconded by Councilperson Glor and carried by unanimous vote to commission Greg Townsend to do the surveys of all town land as recommended by Superintendent Dennis.

Cemeteries---there are two spring burials left; they are being scheduled The mowers are to be mowing the cemeteries two times per week.

Park---everything is fixed and working well.

Equipment---Superintendent Dennis requested permission to place an ad for sealed bids on the old one ton truck. The new one is in. He recommends a minimum sealed bid of \$10,000.00 for the truck which included the plow. The truck is 12 years old, and this dollar figure is based on Kelly Blue Book. A **motion** was made by Councilman Kabel, seconded by Councilperson Glor and carried by unanimous vote to sell the one ton with a minimum bid of \$10,000.00 with plow. The bids will be awarded at the June 14th Board meeting.

Mini Excavator---Superintendent Dennis attended the Village Board meeting last night to discuss having the Village pass a motion that should the Town purchase the mini excavator the Village could use the machine through shared services. Currently, the town rents a machine from Ray Smith, and one is always available should the Town need the machine but they never know where it's going to be. Neighboring Towns want to use the mini excavator. At the County Highway meetings, each town discusses who will buy what piece of equipment so they can all us them through shared service. The money for this piece of equipment will come from fund balanced in the DA & DB funds. This machine has a 10 year life expectancy. A **motion** was made by Councilman Cianfrini, seconded by Councilperson Glor and carried by unanimous vote to purchase the mini excavator for \$56,000.00 and trailer for \$7,600.00 on Federal Bid. Library---the heating is done and Dennis Rettke has asked that the Town simply write him a letter of thank you for the donation he has made to the Library through his work. A **motion** was made by

Councilman Kabel seconded by Councilperson Glor and carried by unanimous vote to send a letter of thanks and accept the donation from Dennis Rettke.

Water Standards---the Town needs to set a meeting date with the Village and Clark Patterson to review these standards. It was also stated that the Town and Village should have another cooperation meetings. Deputy Supervisor Veazey will contact Mayor Pastecki to set a date once we get dates from Clark Patterson.

PESH---it is a requirement of PESH that all employees of the Town who draw a paycheck have ID badges. Superintendent Dennis has a sample badge and the badges cost \$10 each through the county. It was decided that the Town would have the pictures take on May 25th from 2pm-5pm.

The Insurance Committee which consists of Councilperson Glor and Councilman Kabel met with Dan Hale of Shepard, Maxwell and Hale along with Melissa Haacke as Co Chair of the Oakfield Betterment Committee regarding Special Event Insurance for the Days in the Park Event. It had been suggested by various other insurance companies that the Betterment Committee should look into going under the umbrella of the Town's Insurance. After some discussion with the Board it was determined that the Town would get a Special Events quote and the Betterment Committee would get some stand alone quotes and revisit the subject when the quotes for this insurance become available.

Town Clerk Haacke stated that she has again inquired with Brent from Clark Patterson regarding the \$60,000.00 that had to be transferred from General Fund to cover a check for Water District 2. Mrs. Haacke has spoken with Kathy Dear from Stuart Brown's office but with no resolution. Brent stated that he would look into the matter and get back to the clerk so that the \$60,000.00 could be returned to General Fund.

Town Clerk Haacke stated the Dog Renewals are complete and will be mailed at the end of this month.

The Clerk also reported that there have been several Service Charges on the Justice Account over the last couple of months. The total cost has been \$170, which is continuing to place the account in the red. It was recommended that the Town Clerk talk to Sherrie at the Branch in Oakfield.

The Town received a letter from the insurance company regarding the Carroll claim at the Library. The insurance company is closing the case at this time due to lack of response.

Smoke Free Now presented the following resolution to the Board:

Town of Oakfield Tobacco-Free Resolution

Section 1: Rationale

WHEREAS, the Town believes that tobacco use in the proximity of children and adults engaging in or watching outdoor recreational activities at Town-owned or operated facilities is detrimental to their health and can be offensive to those using such facilities; and

WHEREAS, the Town has a unique opportunity to create and sustain an environment that supports a non-tobacco norm through a tobacco-free policy, rule enforcement, and adult-peer role modeling on Town-owned outdoor recreational facilities; and

WHEREAS, the Town believes parents, leaders, and officials involved in recreation are role models for youth and can have a positive effect on the lifestyle choices they make; and

WHEREAS, the tobacco industry advertises at and sponsors recreational events to foster a connection between tobacco use and recreation; and

WHEREAS, cigarettes, once consumed in public spaces, are often discarded on the ground requiring additional maintenance expenses, diminish the beauty of the Town's recreational facilities, and pose a risk to toddlers due to ingestion; and

WHEREAS, the Town Board determines that the prohibition of tobacco use at the Town's recreational facilities serves to protect the health, safety and welfare of the citizens of our Town.

THEREFORE, be it resolved that tobacco use is prohibited in outdoor recreational facilities. No person shall use any form of tobacco at or on any Town-owned or operated outdoor recreational facilities, including the restrooms, spectator and concession areas. These facilities include [Elroy D. Parkins Park, also known as Little League Park].

Section 2: Enforcement

- 1. Appropriate signs shall be posted in the above specified areas.
- 2. The community, especially facility users and staff, will be notified about this policy.
- 3. Staff will make periodic observations of recreational facilities to monitor for compliance.
- 4. Any person found violating this policy may be subject to immediate ejection from the recreation facility for the remainder of the event.

Section 3: Effective Date

This policy statement is effective immediately upon the date of adoption, which is May 10, 2011. Appropriate Town Official Date

A motion was made by Councilman Cianfrini, seconded by Councilman Kabel and carried by unanimous vote to approve participation in Smoke Free Now.

Dear Mr. DiMatteo:

Thank you very much for forwarding to me the Memo, dated April 21, 2011, along with the enclosures referred to therein. I am enclosing the following that I reviewed from my research:

- 1. Office of Real Property Tax Services Opinion of Counsel, Volume 11:45.
- 2. Colleges of the Seneca v. City of Geneva.
- 3. Spectapark Associates v. City of Albany.

I also talked with the Town of Oakfield Assessor, Barry Flansburg. He basically stated that he would exempt the water tower and/or the Town property based upon the documentation that is provided to him. The enclosures that I provided suggest that we could have an agreement by and between the Town of Oakfield and the Village of Oakfield which would make the water storage tank part of the real property. It could then be tax exempt, since any Town of Oakfield property located within the Town that is being used for a municipal purpose would be entitled to an exemption. This would be most similar to "standard" rental agreements in which improvements built upon rental property are assessed as part of the real property.

The second alternative would be to enter into agreements pursuant to Section 406 of the Real Property Tax Law, whereby the Village of Oakfield would maintain separate title to the water storage tank and obtain exemptions by separate agreements with the School District, the County and the Town. It is my understanding that the School District and the County are willing to cooperate in this regard.

With regard to the length of any lease or tax exempt agreements, the Town Assessor has not experienced or been made aware of any instances when the exemption has been terminated by one of the taxing authorities based upon a claim that the agreement could not bind a municipality for a period of time as long as the term set forth in any agreement. Therefore, I would suggest that the length coincide with the loan re-payment period for any bonding obtained by the Village of Oakfield for the project.

Please advise as to your thoughts on how we should proceed. The Town needs to have an agreement in place before purchasing the property.

LIBRARY LIAISON

The Library Board will hold a dedication in the Honor of Norm Fagnan on May 20th from 7-8:30 pm. The actual dedication ceremony will take place at 7:30 pm.

The Library Director would like to meet with the Park Recreation Director to work out some time for the children to enjoy the library during the summer months.

GAM

Mark Masse from GCEDC spoke regarding the Foreign Trade Zone.

The Town should also expect a survey regarding Health Benefit Insurance which is due May 17, 2011. Councilperson Glor was informed that the Town has received the survey and that it has already been mailed back.

The Personnel Committee will be setting up a time to meet with the men for contract negotiations.
