SUPERINTENDENT OF HIGHWAYS

- 1) Road Work Update
 - a) Cutting-down dead trees along road sides where needed.
 - b) Mowing road sides at a halt due to change in weather.
 - c) Trying to schedule putting up snow fence with Alabama highway, the weather is factor in doing so.
- 2) Building & Grounds
 - a) Everything is in working order.

- b) Would like to get estimate to complete building at land-fill with a concrete floor, interior lighting, exterior lighting (both with led lighting), and new overhead doors. Most work to be completed by town work force. Would like a resolution to proceed.
- 3) Cemeteries
 - a) Cleaning up on a continual bases.
 - b) Three trees are left to be cut down in Cary Cemetery.
 - c) Planning on paving main driveways this year. Where will funds come from to pay for? (Will need to wait till 2019 or 2020)
 - d) Revenues on schedule with budget.

Parks

- a) We are looking at some up-grades to park with our Engineers so we can apply for grants as they become available and talk to little league, betterment committee for financial assistance. We may want to consider doing this work and possibly banning it. The drawings are revised now. The cost est. is by Clark-Patterson.
- b) We need to discuss next steps in the park up-grades. Little league wishes to be involved along with youth rec.
- c) Would like to revamp current baths to uni-sex handicap accessible. Most of the work to be done by town forces.

MOTION Councilman Kabel, second Councilman Wolcott to move forward with revamping but leave male/female, remove urinal and add new doors.

- 4) Equipment Update
 - a) Truck 202 is all fixed and running great along with trucks 203 & 201.
 - b) Equipment all ready for winter.
 - c) Roller up-grade and five year replacement program all in place.
 318 Excavator up-grade also in place along with five year lease program with Caterpillar financial for both the roller and excavator.
- 5) Publics Works Update
 - a) WD 7 SERGI needs to come back to do some touch-up restoration.
 - b) WD 9 & 3 has some meter pit repairs needed to be done.
 - c) WD 10 is out to bid, January 4, 2019 bid opening and town board will award at January 8th meeting.
 - d) WD 11 ext. Lewiston Road being worked on by Clark Patterson.
 - e) Phase 2 Alabama is completed except for restoration in spring of 2019.
 - f) Clark Patterson has started laying out sewer districts for future expansion and current needs in the town, also creating a sewer district where there is already sewer in the town. Village will be at all future meetings on sewer.
 - g) Monroe Water Authority in future is the way to go. Waiting for city to sign a contract with MCWA first before that can happen.
 - Need to pursue getting together with village with Town Board, Town Attorney, County Attorney, County Highway Superintendent, Village Board, and Village Attorney on water debt distribution.

- i) Ransco will be installing master meter pits at Drake Street, Maltby Road, and Lockport Road under Elba phase 2 and 3.
- 6) Library
 - a) Working with CPL for elevator install at the library. CPL has come took pictures and measurements and done preliminary drawings. Estimate looks very good, the library is working on getting grant money to install.
- 7) Miscellaneous

a) Need to set up meeting on possible housing development plan areas for Town of Oakfield a developer has already been here for info on locations for housing tracts.

- b) Land fill will open for the whole year weather permitting access.
- c) Working with a solar company on a solar field installation. Nothing new to report.
- j) Need to revise and up-date our zoning codes and town required permits.
- k) DEC has completed the Landfill Inspection waiting for the report.
- Like to pursue setting up a town wide drainage district. Will be some engineering costs up front then add a general fund budget item. Working with Home Land Security on possibly some funding. Would like a resolution to proceed.
