ASSESSOR

The total value of the Town & Village is up \$9.2 million Taxable value up \$6.2 million and the state says it still isn't high enough Sales are coming in 15-20% above assessment

SUPERINTENDENT OF HIGHWAYS

- 1) Road Work Update
 - a) Hope-fully Plowing and treating roads and streets as finished.
 - b) Fixing road signs as needed.
 - c) Intersection lighting change to LED working with National Grid and adding three street lights: the curve on Fisher Road by Depew Rod & Gun, intersection of school drive and Maltby Road, and intersection of Maltby Road and Judge Road. Need approval to add 3

lights.

RESOLUTION NO. 19-2019—LED LIGHTING WITH NATIONAL GRID ADDITIONAL LIGHTING Councilman Carroll offered the following:

WHEREAS, the Town of Oakfield will add three (3) additional street lighting poles the first at the Intersection of Maltby Road & Judge Road nearest pole # is 600 feet west is #2827, second is Maltby Road Intersection of school driveway at pole #3015 and third is Fisher Road on curve by Depew Rod & Gun pole #3486 at a cost of \$33,800.00.

- d) Will be doing pothole patching and crack sealing.
- e) Trees that need to be taken down on road side ROWS for now have been taken care off.
- f) Need approval of road side mowing contract with the State DOT.

RESOLUTION NO. 20-2019—NYS DOT MOWING CONTRACT

Councilman Wolcott offered the following:

WHEREAS, the Superintendent of Highways has been notified by NYSDOT of the Roadside Mowing Agreement; and

THEREFORE, BE IT RESOLVED, the Town of Oakfield shall enter into the 2019 Roadside Mowing Agreement with NYSDOT.

- g) Need approval to hire road side spraying contract same as last year. DOT will be spraying their road sides. MOTION Councilman Wolcott, second Councilman Carroll to approve the hiring of a contractor to spray roadsides for weeds.

 MOTION CARRIED UNANIMOUS VOTE (4-0)
- 2) Building & Grounds
 - a) Need approval to replace rear door on highway garage employee entrance for a cost of \$2383.00 see quote from Alliance Door.
 MOTION Councilman Kabel, second Councilman Carroll to approve the replacement and correction of swing direction of highway garage employee entrance, not to exceed

\$2,383.00.

Ayes: Martin, Carroll, Kabel, Wolcott APPROVED UNANIMOUS VOTE (4-0)

b) Working with contractors to complete building at land-fill with a concrete floor, interior lighting, exterior lighting (both with led lighting), and new overhead doors. Most work to be

completed by town work force. (work not to exceed \$15000.00) Concrete Floor is completed.

- c) MJ Mechanical working on heating system, also Clark Patterson. MJ Mechanical is working up a quote for maintenance of library boilers.
- 3) Cemeteries
 - a) Three trees are cut down in Cary Cemetery. All trees are finished.
 - b) Planning on paving main driveways this year. Where will funds come from to pay for? (Will need to wait till 2019 or 2020)
 - c) Will be starting spring clean-up and rolling.
- 4) Parks

We are looking at some up-grades to park with our Engineers so we can apply for grants as they become available and talk to little league, betterment committee for financial assistance. We may want to consider doing this work and possibly banning it. The drawings are revised now. The cost est. is by Clark-Patterson.

- a) We need to discuss next steps in the park up-grades. Little league wishes to be involved along with youth rec.
- b) Working on schedule to revamp current baths to handicap accessible. Most of the work is being done by town forces.
- c) Will be starting spring clean-up and rolling.
- 5) Equipment Update
 - a) Equipment all running good.
 - b) All excavator operators MUST BE CERTIFIED by May 4st, 2019 by State Law.
- 6) Publics Works Update
 - a) WD 7 SERGI needs to come back to do some touch-up restoration.
 - b) WD 9 & 3 has some meter pit repairs needed to be done.
 - c) WD 10 under construction. E & R doing a good job so far.
 - d) WD 11 ext. Lewiston Road being worked on by Clark Patterson and Oakfield Public Works Administrator along with GCEDA.
 - e) Phase 2 Alabama is completed except for restoration this spring (2019).
 - f) Clark Patterson has started laying out sewer districts for future expansion and current needs in the town, also creating a sewer district where there is already sewer in the town. Village will be at all future meetings on sewer.
 - g) Monroe Water Authority in future is the way to go. Waiting for city to sign a contract with MCWA first before that can happen.
 - Need to pursue getting together with village with Town Board, Town Attorney, County Attorney, County Highway Superintendent, Village Board, and Village Attorney on water debt distribution.
 - i) Lockport Road master meter pit is under Elba phase 3 at Oakfield/Elba town-line.
- 7) Library

- a) Working with CPL for elevator install at the library. CPL has taken pictures and measurements and done preliminary dwgs. Estimate looks very good, the library is working on getting grant money to install.
- 8) Miscellaneous

a) Need to set up meeting on possible housing development plan areas for Town of Oakfield a developer has already been here for info on locations for housing tracts.

b) Land fill is open for the whole year weather permitting access.

Working with a solar company on a solar field installation. Nothing new to report.

- c) Need to revise and up-date our zoning codes and town required permits. Need a fill permit, Highway construction permit, over weight permit, over width permit, and others as needed.
- d) DEC has completed the Landfill Inspection waiting for the report.
- e) Like to pursue setting up a town wide drainage district. Will be some engineering costs up front then add a general fund budget item. Working with Home Land Security on possibly some funding.
- f) Alan will be off Wednesday and possibly Thursday wife is having surgery. April 16th will be in Syracuse for NYMIR meeting, and Suite-Kote training April 17th in Perry.
