RESOLUTION NO. 48-2020—RESOLUTION AUTHORIZING THE SUPERVISOR OF OAKFIELD TO ENTER INTO A COURT FACILITIES AGREEMENT WITH ALABAMA

Councilman Kabel offered the following:

WHEREAS, the Towns of Oakfield and Alabama have proposed a joint agreement whereby the Town of Alabama would use the Oakfield Court Facilities to conduct court at a cost of \$6,600 per year to the Town of Alabama for a period of 3 years, and

WHEREAS, the Town of Alabama has determined that currently it would be in the best interest of the residents of the Town to enter into an Office and Court Facilities Temporary Lease Agreement with the Town of Oakfield to use their Court Facilities, and

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Oakfield, New York, that a proposed "Office and Court Facilities Temporary Lease Agreement" between the Town of Alabama is hereby approved, and

BE IT FURTHER RESOLVED, that the Oakfield Town Supervisor is hereby authorized and directed to execute this Office and Court Facilities Temporary Lease Agreement on behalf of the Town of Oakfield

BE IT FURTHER RESOLVED, which this resolution is subject to a 30 day Permissive Referendum and that the Town Clerk is directed to publish a copy of this resolution in the Batavia Daily News.
