As I stated in my 5/19/2021 email if the Village and Town are submitting the perm-33c Application then it is your event and all the requirements shall come from the Village and Town. The Town is listed as an co-applicant, the village and the town are equally responsible for the event.

If the Town and or Village does not wish to regulate the event then the event organizer is required to submit a perm-33b Application along with \$5,000,000.00 in insurance, detour plan, COVID-19 plan, safety plan and emergency contact information.

Many municipalities do not realize that by submitting the perm-33c Application they are responsible and assume all the liability for the event.

OTHER BUSINESS

Supervisor Martin brought up the issue with the Village regarding Fire Protection

For years, but recently the past few months Supervisor Martin and Councilperson Glor have been trying to negotiate with the Village a service contract that is equal. Currently, the Town pays 58% of the fire budget. Supervisor Martin requested that the number become a 50/50 split over a three year period, which the Mayor and Village Board refuse to entertain. At this time the Town has not paid the village for the last village budget year. Supervisor Martin says this is not a contract it is a service agreement and should be treated as such. A proposal to the Village of \$63,000.00 per year for three years on a service contract appears to be rejected as there has not been any communication from the Mayor.
