STATEMENT FROM TOWN BOARD REGARDING FIRE AGREEMENT WITH VILLAGE OF OAKFIELD

At this time, the Town has not been served with any legal action

For 5 years, the Town of Oakfield has been trying to work with the Village of Oakfield to come to a fair and equitable Fire Agreement. The Town would like to see

A three year contract

A service contract only—not to include capital because the Village owns all Fire Equipment.

The Town Board disagrees with the content of the letters being circulated, including the \$1.62 being allocated to Fire Protection to the Village residents. The total taxable value of the Village is \$52,040,355 (for bills sent out in June 2021)

Based on the Mayor's statement that \$1.62 of the village rate is for fire, they raised \$84305.38 for Fire Service within the village alone.

The Village Budget for 2021-2022 for Fire is \$95,000.00. Of that 95K, \$10,320 is earmarked to go into a truck reserve. If you take that out of the \$95k you are left with \$84,680 for a total operating budget. So 58% (Town) is \$49,126.

So, if the Village collected \$84,680 and the Town owes them \$49,126 then the total budget would be \$133,806. What are they doing with the other \$39K they collected if they did in fact collect it.

This should make the Village fire tax rate 0.89 cents/1K

We also disagree with there being 10 structure fires within the Town of Oakfield. When a fire happens within our boundaries both the Assessor and Code Enforcement Officer is contacted. Neither have been contacted for structure fires with the Town.

Finally, in an attempt to sit at the table with the Village and negotiate an agreement, the Town sent the Village a check for \$39,322.36 (half of the \$78644.71) the Town collected. The Village still has the check, refuses to cash it and will not entertain a discussion.

After the statement was read by Councilperson Glor, Supervisor Martin opened the floor to public comment.

Buck Hilchey stated that the tax payer must come first, what is the Town's plan come November 30th?

Supervisor Martin stated the following:

Currently being handled by attorney
Researching the situation

This has never been an issue before, why now? Mr. Hilchey feels the Town should pay what is owed as the Fire Department performed well.

It was stated that the Town has no issue with the Fire Department. The issue is with the agreement and that the Village continues to cut the Fire budget. The Town has budgeted \$15,874 more than what the Village put in their budget because the Town feels the Fire Department needs more funding.

Mrs. Hilchey again asked the question, "but what happens on November 30th if this isn't resolved?" Councilperson Glor assured the Town residents that they will not be without fire protection.

Ms. DeCenso asked if there is not a resolution if the school would be taken care of as it is in the Town.

The answer is "no" because the Fire Department cannot leave the village boundaries.

Chief Downey stated that the Village cannot pick and choose where the Fire Department goes.

Karl Dilcher asked about what this is going to do to homeowner insurance if this is not resolved.

Joel D'Alba stated that if the Town collected the money is should be paid. Then asked what the fire tax rate will be in 2022.

Assessor Flansburg stated it will 0.49 cents/1000 based on the proposed Town Budget of \$65,000

Dan Luker then stated that there is no reason the fire issue has come to this, "I don't believe that the Village has cut the budget by 50%. Why is the Town taking issue with the Fire Department?"

Assessor Flansburg again stated that the Town has no issue with the Fire Department, we want to resolve this issue.

Supervisor Martin stated that the Village refuses to meet on this subject. Chief Downey confirmed that the Village in fact cut the fire department budget by 58%.

Mr. Luker stated that he will look into all this, but the Town accepted the service for a year so the money should be paid.

Chief Downey, too wanting to resolve this situation asked the Town Board if a meeting was set with the Fire Department, Mark Butler (Fire Department Attorney), Town of Oakfield, Town Attorney, and Village and their attorney would they come to the table. All Board members in attendance welcomed that offer.

YOUTH RECREATION

Joel D'Alba stated that the Youth Commission would like to meet with the Town Board Councilperson Glor stated that she, Melissa Haacke and Melissa Domoy met Mr. D'Alba stated that Mrs. Domoy showed the Youth Commission the list of concern and they want to address them.

ROAD CONCERN

Matt Santy of Lockport Road asked Superintendent of Highways Schultz if anything will be done to correct the issue in front of his driveway. There is quite a "lip" since the County widened the road. Superintendent Schultz stated that he called the County, but is unsure if they will correct the issue.
