RESOLUTION NO. 8-2022—RESOLUTION AUTHORIZING PARTICIPATON IN THE YEAR 2022 JOINT YOUTH PROGRAM

Councilperson Glor offered the following:

WHEREAS, the Town of Oakfield has previously set up and administered a Joint Youth Program with the Village of Oakfield, Towns of Alabama and Batavia, and

WHEREAS, the Town of Oakfield's contribution to this joint project has most recently been approved in the amount of \$5,650.00, and such contribution qualifies for a fifty percent (50%) NYS State Aid reimbursement, or the maximum allowable according to the State Aid Eligibility Summary for the Program Year as provided by Genesee County Division for Youth; and

WHEREAS, the Oakfield Town Board has deemed this Joint Youth Project to be worthwhile and of distinct benefit to area Youth, and the Town wishes to continue participation in this youth project.

NOW THEREFORE, BE IT RESOLVED, that the Year 2022 Joint Youth Project as herein described, is approved, as is the Town's contribution of **\$5,650.00**.

Aides: \$13.20 hr. X 32.5 (9:00-4:00) = 429.00 per week X 5 week program=\$2145 X 5 Aides (see attached resolution)= \$10,725.00

Leader \$3200 salary

Total Payroll expense: \$13,925

Revenue all governments

\$16040.00

\$2115 remaining for 2022

If you add the 6th Aide you have negative fund balance of (\$30) before any yearly expenses for the program. Current fund balance for the program is \$7,344.52.

Your expenses for 2021 were \$4200, which includes the \$1200 for the ski trip.

I am just pointing this out as the committee is very close to being out of money by 2023.

Your committee needs to attend the February board meeting and discuss this with the board. The meeting is February 8th at 6:30 pm. If there isn't enough money to run the program we have to work out a solution, but this is what is budgeted and there is nothing more to come in.
