Of the two for \$598 each, one will be at the front counter for the main Clerk's program and DEC, the second at a cost of \$598 will house the scanning program for records retention, IPS, the sign board, and bank scanner.

BE IT FUTHER RESOLVED the computer costing \$1,098.00 for the Town Clerk. This computer will have full Microsoft programs, capabilities for records retention, state programs, and storage.
