DEPUTY SUPERVISOR WOLCOTT

The Deputy Supervisor reported that he attended a meeting with GCEDC regarding STAMP. Edwards is coming along, and 280 employees are expected there in January 2026.

Data centers will employ 122 employees, within three buildings. It will be approximately two years for these to be completed.

They also attended a meeting on Alabama Solar. There really aren't any restrictions on solar companies.

The solar companies have a choice to pay taxes or enter into a PILOT for ten years, after that, they are tax exempt.

Continuing to work on the sewer project.
