Mrs. Domoy stated that she felt that she and Mr. Manges were told in March of 2022. The minutes of the March 2022 minutes were then put up on the screens to show that the minutes once again referenced the July 2021 minutes of only 5 aides were to be hired.

RESOLUTION NO. 18-2022—CONCERN OF HAZARDOUS INTERSECTION ROUTE 63 & TOWNLINERoads

WHEREAS there have been numerous accidents at the intersection of Route 63 and Townline Roads, including two within a two-week time frame;

WHEREAS, Route 63 is a State Road and Townline Roads are County Roads, the Town cannot place additional signage.

THEREFORE, BE IT RESOLVED that the Town Board will forward this concern and resolution to the Genesee County Legislature in hopes that NYSDOT will investigate improving this intersection.
