**RESOLUTION NO. 32-2022—LOCAL LAW NO. 1-2022—“19 NYCRR PART 1203 OF PART 1203 UNIFORM CODE AND ENERGY CODE: MINIMUM STANDARDS FOR ADMINISTRATION AND ENFORCEMENT WITH AMENDMENTS”**

Deputy Supervisor Wolcott offered the following:

**WHEREAS**, proposed Local Law No 1 of 2022 of the Town of Oakfield entitled “19 NYCRR Part 1203 of Part 1203 Uniform Code and Energy Code: Minimum Standards for Administration and Enforcement with Amendments”, which proposed Local Law in its final form was presented to the Town Board at the meeting held on December 13, 2022, and a copy thereof was kept with the Town Clerk and copies both laid upon the desks of the members of said Town Board and mailed to each member of the Town Board Members not in attendance of said meeting; and

**WHEREAS**, a public hearing on the advisability of enacting said proposed Local Law was held on December 27<sup>th</sup>, 2022, before this Town Board, pursuant to public notice duly published in The Daily News according to law, at which time all interested persons were heard; and

**WHEREAS**, the Town Board of the Town of Oakfield, New York is of the opinion that adoption of said proposed Local Law No. 1 of 2022 is in the best interest of the Town of Oakfield, New York,

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Board of the Town of Oakfield, New York that said proposed Local Law No. 1 of 2022 be and the same hereby is adopted, and such Local Law shall be entered in the minutes of the Oakfield Town Board; and

**BE IT FURTHER RESOLVED**, that a certified copy of said Local Law No. 1 of 2022 be filed with the New York State Secretary of State in accordance with the Law.
